Boat Numbers:

- Boat launch order will be determined by registration order.

Regulations:

- Any type of Boat may be used (except airboats or stick steering boats), provided the motor does not exceed the specified horsepower and boat has following
- Aerated and/or re-circulating livewell
- Boat must have operational kill switch
- Navigational lights must be used pre-sunrise
- Life Jackets MUST BE WORN while boat is underway or any time the main engine is running
- Only artificial baits may be used. No live or cut bait is permitted
- All Bass must be caught alive in a legal and sporting manner. No snagging.
- Each competitor may only use 1-rod at a time. No more than 1-line in the water at a time per angler
- Trolling as a way of catching fish is not permitted
- Dead Fish Penalty—1/4 lb deduction for weighing a dead fish. Any boat caught culling a dead fish will be disqualified.
- There is a 5-Fish Limit. At no time may there be more than 5 fish in the livewell. We will have exemptions available there-fore the minimum length is 12” and multiple fish over 22” will be allowed to be weighed in.
